3. 16th Bond Coupon of the Wijaya Karya Shelf Registration Bond II Phase II Year 2022 Series C (WIK02CCN2);
4. 16th Revenue Sharing of the Wijaya Karya Shelf Registration Sukuk Mudharabah II Phase II Year 2022 Series B (SMWIK02BCN2);
5. 16th Revenue Sharing of the Wijaya Karya Shelf Registration Sukuk Mudharabah II Phase II Year 2022 Series C (SMWIK02CCN2);

Such matter indicates an issue on the Company’s business continuity.

In view of the above, the Indonesia Stock Exchange (“**IDX**”) has decided to continue the temporary suspension on the trading of PT Wijaya Karya (Persero) Tbk (WIK0) in All Markets until further notice from the **IDX**.
