PURSUANT TO THE GOVERNMENT REGULATION NO. 56 SIGNED INTO LAW ON 4 AUGUST 2015, THE CONDITIONS TO OBTAIN A REDUCTION IN INCOME TAX RATE ARE AS FOLLOWS:

- AT LEAST 40% OF THE TOTAL PAID-UP SHARES ARE LISTED ON THE INDONESIA STOCK EXCHANGE
- SUCH SHARES MUST BE HELD BY AT LEAST 300 SHAREHOLDERS AND EACH SHAREHOLDER MAY ONLY HOLD LESS THAN 5% OF THE TOTAL PAID-UP SHARES. THE CONDITIONS MUST BE MET FOR AT LEAST 183 CALENDAR DAYS IN 1 TAX YEAR
