UNDER THE GOVERNMENT REGULATION NO. 30 ENACTED ON 19 JUNE 2020, THE CONDITIONS TO BE ENTITLED TO AN INCOME TAX DEDUCTION AREAS FOLLOWS:

- AT LEAST 40% OF THE TOTAL PAID-UP SHARES ARE LISTED ON THE INDONESIA STOCK EXCHANGE
- SUCH SHARES MUST BE HELD BY AT LEAST 300 SHAREHOLDERS AND EACH SHAREHOLDER MAY ONLY HOLD LESS THAN 5% OF THE TOTAL PAID-UP SHARES. THE CONDITIONS MUST BE MET FOR AT LEAST 183 CALENDAR DAYS IN 1 TAX YEAR
