1	<p>On the facts of the news.</p> <p>In relation to the news “Lima Tim Investigasi LRT” (“Five Teams to Investigate LRT Incident”) reported by <i>Harian Kompas</i> on 26 January 2018, we wish to submit the following clarifications:</p> <ul style="list-style-type: none"> • The Jakarta LRT Project has entered the last phase of construction for section 1 (one), i.e. erection of box girders. On Monday, 22 January 2018 at 00.20 WIB, the Jakarta LRT Project has completed the stressing of box girders for span P28-P29 on Jl. Kayu Putih Raya, Pulo Gadung, East Jakarta. • The stressing was carried out by PT VSL Indonesia. Security around the work area was coordinated by the traffic management and safety teams by closing the road next to the incident site. • A few moments after the stressing was completed at 00.20 WIB, an incident occurred on span P28-P29. • The cause of the incident is still under investigation by the relevant authorities. Nonetheless, early indications suggested that the incident would not disrupt the completion schedule of the project and robustness of erected structures. • Swift handling of the incident by the project management is expected to ensure that the project is completed on-time to support the Asian Games 2018.
