1. Date of Event

Date of event is 1 November 2024, i.e. the date of the PKPU petition. The petition was published on the Case Tracking System of the Jakarta Pusat District Court (*Sistem Informasi Penelusuran Perkara Pengadilan Negeri Jakarta Pusat*, "SIPP PN Jakpus").

2. Type of Information or Material Facts

PKPU petition filed by PT Wiradjaja Prima Kencana against the Company on the Company's obligation to repay its debt.

3. Description of Information or Material Facts

In accordance with the PKPU petition published on SIPP PN Jakpus and the court summons received by the Company issued by the Special Class IA of the Central Jakarta District Court (*Pengadilan Negeri Jakarta Pusat Kelas I A Khusus*) No. 329/Pdt.Sus-PKPU/2024/PN Niaga Jkt.Pst on PKPU petition. The petition was filed by PT Wiradjaja Prima Kencana as the Petitioner against the Company as the Respondent. In its petition, the Petitioner claims that the Company has an outstanding debt of Rp7,206,616,312. The Company wishes to inform that it have repaid Rp1,110,319,088 from a total sum of Rp8,316,935,400 on 13 September 2024 and will repay the outstanding amount.

4. Impacts of Event, Information, or Material Facts

We wish to inform you that the PKPU claim mentioned above does not significantly affect the financial or operational performance of the Company.
