We refer to the letter from PT Bursa Efek Indonesia ("**IDX**") No. S-11241/BEI.PP2/10-2024 dated 29 October 2024 on IDX Queries. PT Wijaya Karya (Persero) Tbk ("**Company**"), the parent entity of PT Wijaya Karya Industri & Konstruksi ("**WIKON**"), wishes to inform and clarify the following:

1. Clarification on the Event

a. Background of the claim against PT Wijaya Karya Industri & Konstruksi filed by PT Infinite Berkah Energi

WIKON has an outstanding payment to PT Infinite Berkah Energi ("**IBE**") on the energy supply bill for its project.

b. The value of the claim and the Company's assessment of the materiality of the claim

At time of writing, WIKON has not received the PKPU notice and is not aware of the value of the claim filed by IBE.

c. WIKON's contribution to the Company's revenue in the Financial Statements ended on 31 December 2023 and 30 September 2024.
