Subject : **Response to IDX Queries: Clarification concerning Petition for Debt Suspension**

Dear Sir/Madam,

We refer to the letter from PT Bursa Efek Indonesia (“**IDX**”) No. S-00553/BEI.PP2/01-2025 dated 17 January 2025 on IDX Queries. PT Wijaya Karya (Persero) Tbk (“**Company**”) as the parent entity of PT Wijaya Karya Industri & Konstruksi (“**WIKA IKON**”) wishes to inform and clarify the following:

1. Clarification on the event

a. Background of the claim and petitioner

A petition for debt suspension (*Penundaan Kewajiban Pembayaran Utang*, “**PKPU**”) against WIKA IKON was refiled by PT Delta Niaga Sinergi (“**DNS**”) through the Commercial Court at the Special Class IA of the Central Jakarta District Court.

b. Background of the claim against PT Wijaya Karya Industri & Konstruksi refiled by PT Delta Niaga Sinergi

The value of the claim is Rp842,122,452 (eight hundred forty-two million one hundred twenty-two thousand four hundred fifty-two Rupiah), which has been previously rejected by the court. Consequently, DNS refiled a PKPU petition No. 7/Pdt.Sus-PKPU/2025/PN.Niaga.Jkt.Pst dated 15 January 2025 through the Central Jakarta Commercial Court.

c. Is the petition considered material? If yes, please explain the value of the claim and the Company's assessment of the materiality of the claim

The value of the claim is not material.

d. WIKA IKON's contribution to the Company's revenue, assets, and equity in the latest Financial Statements
